

# NOTICE OF DELINQUENT PROPERTY TAX LIST

Public notice is hereby given, that I, Twyla Bailey, County Collector of the County of Crawford, in the state of Illinois, shall apply to the Circuit Court of said Crawford County, on the 4th day of November, A.D. 2020, thereof, for judgement against the lands, lots and leaseholds, for the taxes, special assessments, interest and costs due severally thereon for the years A.D. 2019 and for an order to sell said lands, lots, and leaseholds, for the satisfaction thereof, and also for judgement fixing the correct amount of any tax under protest.
