### **Crawford County Sheriff's Office Press Release**

*The following subjects have been charged with a crime but are presumed innocent until proven guilty:*

On January 28, 2024 approximately 08:39 Crawford County Deputies responded to a single vehicle accident CR 2000E near E. River Road in LaMotte Township. Gregory Redman, age 59, of rural Palestine driving a 2010 GMC Sierra. Redman was traveling east and met an unknown vehicle and position himself to the side of the roadway due to the weather the roadway was soft and guided his vehicle in to a ditch causing over \$1,500 in damage. No injuries reported and the vehicle was drivable from the scene.
