### **Crawford County Sheriff's Office Press Release**

*The following subjects have been charged with a crime but are presumed innocent until proven guilty:*

On January 4, 2024 approximately 10:07 Crawford County Deputies executed a search warrant near the 400 block of E. Mechanic Street in Hutsonville. Upon the investigation deputies arrested Monica Heleine, age 37, of Hutsonville for; Unlawful Possession of Methamphetamine. Deputies also arrested William H. Brackett, age 37, of Hutsonville for; Unlawful Delivery of Methamphetamine, Unlawful Possession of Methamphetamine and Unlawful Possession of Drug Paraphernalia. Both were transported to the county jail for processing. Heleine was later released with a future court date reference the Pre-trial Fairness Act. Brackett remains in custody awaiting a detainment hearing.

On January 3, 2024 approximately 23:21 Crawford County Deputies arrested Arturo Rivera, age 40, of Lawrenceville, IL for; Crawford County Warrant - Aggravated Battery. Rivera was transported from the Lawrence County Jail back to Robinson and processed through the jail. Rivera attended a detainment hearing and was later released with a future court date reference the Pre-trial Fairness Act.

On January 3, 2024 approximately 21:03 Crawford County Deputies arrested Chas Siler, age 33, of rural Oblong for: Crawford County Failure to Appear Warrant – (Aggravated Battery and Battery).
