### **Crawford County Sheriff's Office Press Release**

*The following subjects have been charged with a crime but are presumed innocent until proven guilty:*

Part two of January 15, 2024

On January 13, 2023 approximately 05:55 Crawford County Deputies responded to a single vehicle accident IL RT 1 near CR 540N in Honey Creek Township. Phillip Beane, age 43, of Robinson driving a 2018 Dodge Journey allegedly fell asleep traveling north on IL RT 1 then drifted to the west side of the roadway and collided with an embankment causing over \$1,500 in damage. No injuries reported and the vehicle had to be towed by Couse Towing Service.
