The members of the Crawford County Board met in regular session at the Crawford County Annex and by teleconference on Thursday, January 14, 2021. County Board Chair, David Fulling, called the meeting to order at 6:00 p.m.

Pledge of Allegiance was given by all, followed by a moment of silence and prayer led by Jonathon Goff.

Upon roll call Kip Randolph, Mitch Williams, Shane Robinson, Don Goupil, David Fulling, Koert Bartman, Kevin Dart, Jonathon Goff, and Clint Williamson were present. Jim Keller was absent.

MINUTES

OFFICER REPORTS

Reports were given by EMA Coordinator, Brad Midgett; Andrew Hargrave for United Life Care; Madelyn Taylor, Administrator for the Health Department; State's Attorney, Cole Shaner; Treasurer, Twyla Bailey; Coroner, Earl Deckard; County Clerk, Fayrene Wright; and County Sheriff, Bill Rutan. Lisa Schaefer with the Robinson Chamber of Commerce spoke regarding ILLINOISouth Tourism. Written reports were submitted by the Regional Office of Education and Animal Control.

EMA Coordinator Brad Midgett and Greg Newlin reported that they received six bids for the new truck. They accepted the bid from FAST in Lincoln. They will be purchasing the chassis here locally from Silverthorne. The new trailer should be here within the next couple of months.

Andrew Hargrave with United Life Care reported that they responded to a total of 254 calls in December. There were 128 medical, 63 transfers, 19 lift assists and 5 car accidents included in that total.

Madelyn Taylor, Health Department Administrator reported that they will start phase 1b of COVID vaccine distribution next week. This phase with starts with law enforcement and first responders then residents 80 years old and older. They are receiving the Moderna vaccine.

State's Attorney Cole Shaner reported that there will not be any jury trials held in Crawford County until at least March. Even though no jury trials are scheduled court is still be held and individuals are being sentenced to DOC.

Treasurer Twyla Bailey reviewed reports. Utility/rent payments for the Annex have been made and are current. State reimbursements for the State's Attorney, Public Defender and Supervisor of Assessments have been received for December. Representatives from CIC will be on site starting January 19 for training on the new financial software. Twyla also reported that all board members will receive a revenue and expense report from her office each month. Also, the auditors were here in December and are still working on things.

Coroner Earl Deckard reported that his office had a total of 162 cases in 2020, issued 71 cremation permits and had 15 autopsies conducted. The office additionally responded to 5 COVID deaths in December.

Robinson Chamber of Commerce Executive Director Lisa Schaefer spoke of the benefits of ILLINOISouth Tourism. They are moving to a more digital platform and are working on the 2020-2021 Visitor's Guide. She asked that details for any community events be forward to her at the Chamber. She will thereafter forward them to Illinois South.

County Clerk Fayrene Wright reviewed reports. She reported that over half of the deaths registered in her office in December were COVID related. She also asked that board members complete the economic interest statements that were part of their packets and return them to her office as soon as possible.

County Sheriff Bill Rutan reviewed reports. December receipts totaled \$7864.37 which included one Sheriff's sale. Ninety-seven people were booked into jail in December, with an average daily count of 23. Eight hundred eighty people passed through Courthouse security. December transports included two mental health transfers, 9 males to DOC, 4 females to DOC, 5 out-of-county pickups and 4 medical transports. He reported that all inmates were served a traditional Christmas meal. He is working on scheduling a date with U. S. Marshalls regarding housing federal prisoners. The jail inspection is scheduled for next Thursday.
