Minutes of Proceedings "1 of 4" Crawford County Board Thursday, October 13, 2022

The members of the Crawford County Board met in regular session at the Crawford County Annex on Thursday, October 13, 2022. County Board Chair, David Fulling, called the meeting to order at 6:00 p.m.

Pledge of Allegiance was given by all, followed by a prayer by Fayrene Wright.

Upon roll call Kip Randolph, Shane Robinson, Don Goupil, David Fulling, Koert Bartman, Jonathon Goff and Clint Williamson were present. Mitch Williams, Kevin Dart and Garry Wilson were absent.

#### **MINUTES**

**MOTION:** Jonathon Goff moved that the minutes of the September 15, 2022 County Board meeting be approved as presented. Don Goupil seconded the motion. Motion carried unanimously upon roll call.

#### **CLAIMS**

#### **OFFICER REPORTS**

Reports were given by Andrew Hargrave for United Life Care; State's Attorney, Cole Shaner; Mikayla Gascich for the Crawford County Health Department; Coroner, Earl Deckard; Beckie Staley for County Clerk, Fayrene Wright; CCDA Executive Director, Resa Shaner; County Sheriff, Bill Rutan; and County Treasurer, Twyla Bailey. Written reports were submitted by the Regional Office of Education.

Andrew Hargrave reported that United Life Care responded to a total of 273 calls in September including 55 transfers from Crawford Memorial; 6 lift assists and 2 law enforcement assists. There were 19 mutual aid responses to and from other counties.

State's Attorney, Cole Shaner reported that 218 criminal felonies and 85 criminal misdemeanors have been filed to date this year. Thirty of the misdemeanors have been domestic violence related.

Mikayla Gascich reported for the Crawford County Health Department. Covid numbers continue to decline. They are now low enough that they are now testing by appointment. The Health Department will hold an adult drive through flu clinic next Thursday and a walk in one on October 26.

Coroner, Earl Deckard reported that his calls are up compared to this point last year. His office is responding to very few Covid deaths now. Autopsies for the year are down.

Beckie Staley reviewed reports for County Clerk, Fayrene Wright. Beckie reported that the office was busy working on sending out vote by mail ballots for the November election. The election judges training at the Forest Preserve went well. Beckie also reported that the office has hired a new employee who will start on October 31.

CCDA Executive Director, Resa Shaner reported that a Child Care Appreciation Event was held at the Forest Preserve. An informational event for home child care providers will be held on October 18 at Highland Church of Christ. She asked that people check their website at crawfordkids.org or their Facebook page to see their progress. Resa also reported on the Rise Grant program through the Illinois Department of Commerce and Economic Opportunity. The funds are to be used to help local governments and economic development organizations create or update economic plans to promote economic recovery.

County Sheriff, Bill Rutan reviewed reports. September receipts were \$3372.52 with 2 Sheriff's sales. Ninety-seven people were booked into jail in September. One thousand six hundred thirty-one people passed through Courthouse security. Six females were transferred to DOC in September with five males scheduled to be transferred tomorrow. There were 7 medical transports for the month. There are currently two individuals serving sentences in the County Jail.

County Treasurer, Twyla Bailey reviewed reports. She reported that there was a second tax distribution in September. She has received State reimbursements for the Sheriff, State's Attorney, Public Defender and Supervisor of Assessments for September. Twyla reported that certified notices for delinquent taxes went out October 16. October 19 is the last day to pay to avoid publication in the newspaper. October 21 is the last day to pay with a personal check.
