Minutes of Proceedings "1 of 3" Crawford County Board Thursday, September 15, 2022

The members of the Crawford County Board met in regular session at the Crawford County Annex on Thursday, September 15, 2022. County Board Chair, David Fulling, called the meeting to order at 6:00 p.m.

Pledge of Allegiance was given by all, followed by a moment of silence and prayer led by David Fulling.

Upon roll call Kip Randolph, Mitch Williams, Don Goupil, David Fulling, Koert Bartman, Jonathon Goff and Clint Williamson were present. Shane Robinson, Kevin Dart and Garry Wilson were absent.

#### **MINUTES**

**MOTION:** Don Goupil moved that the minutes of the August 11, 2022 County Board meeting be approved as presented. Clint Williamson seconded the motion. Motion carried unanimously upon roll call.

#### **CLAIMS**

#### **OFFICER REPORTS**

Reports were given by Clint Williamson for United Life Care; County Sheriff, Bill Rutan; County Clerk, Fayrene Wright; County Treasurer, Twyla Bailey; Mikayla Gascich for the Crawford County Health Department; CCDA Executive Director, Resa Shaner; and State's Attorney, Cole Shaner. Supervisor of Assessments Hope Weber was present but had nothing to report. Written reports were submitted by the Regional Office of Education.

Clint Williamson reported that United responded to a total of 261 runs in August including 44 transfers from Crawford Memorial; 13 lift assists and 3 law enforcement assists. There were 6 mutual aid responses to other counties.

County Sheriff, Bill Rutan reviewed reports. August receipts were \$5510.15 with 1 Sheriff's Sale. The average daily count at the jail was 39. One thousand four hundred four people passed through Courthouse security. There were 4 medical transports in August and 4 females were transferred to DOC. Currently 10 inmates are waiting for transfer to DOC.

County Clerk, Fayrene Wright reviewed reports. She reported that Early Voting will start on September 29. She also reported that she will be hiring an additional staff member in her office.

County Treasurer, Twyla Bailey reviewed reports. She reported that all rent payments for the Annex are current. The State reimbursements for the State's Attorney, Public Defender, Supervisor of Assessments and County Sheriff have been received for August. Twyla reported that second distribution of real estate taxes was yesterday. She also reported that reminder letters were printed on Monday. Currently 954 parcels are delinquent. Certified notices will go out the first week of October. Taxes need to be paid by noon on October 19 to keep your name out of the paper. Twyla reported that her office also will be hiring a new staff member.

State's Attorney, Cole Shaner reported that to date 195 felonies and 106 misdemeanors have been filed in the County. That is slightly less than this time last year. Cole also reported that on January 1 the new law goes into effect with the new bail system.
