### **Crawford County Sheriff's Office Press Release**

*The following subjects have been charged with a crime but are presumed innocent until proven guilty:*

On February 4, 2024 approximately 19:01 Crawford County Deputies arrested Amanda Campbell, age 34, of Robinson for; Crawford County Warrant – Domestic Battery. Campbell was transported to the county jail for processing. Campbell remains in custody awaiting a detainment hearing. Warrant service 400 block of W. Mulberry St. Robinson.
