### **Crawford County Sheriff's Office Press Release**

*The following subjects have been charged with a crime but are presumed innocent until proven guilty:*

On February 26, 2024 approximately 05:00 Crawford County Deputies responded to a car/deer accident IL RT 33 @ CR 1650E in LaMotte Township. Autumn Burkett, age 46, of Palestine driving a 2023 Toyota Tundra collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was drivable from the scene.

On February 25, 2024 approximately 15:05 Crawford County Deputies responded to a car/deer accident CR 800E near CR 2000N in Prairie Township. Rodger Artman, age 59, of Annapolis driving a 2015 Ram Pickup collided with a deer causing over \$1,500 in damage. No injuries reported and the vehicle was drivable from the scene.
