Crawford County Sheriff's Office Press Release

The following subjects have been charged with a crime but are presumed innocent until proven guilty:

On March 12, 2024 approximately 20:07 Crawford County Correctional Deputies arrested Christine Mackiewicz, age 41, of Vandalia, IL for; Crawford County Warrant – Violation of an Order of Protection. Mackiewicz was extradited from the Fayette County jail back to the Crawford County Jail for processing. Mackiewicz was later released the next day after attending a detainment hearing reference the Pre-trial Fairness Act.

On March 12, 2024 approximately 19:59 Crawford County Deputies arrested two subjects reference a traffic stop CR 1050N near CR 400E in Oblong Township. First, Jessica Contant – Thompson, age 43 of Oblong for; DUI – Drugs, No Valid Registration and Unlawful Possession of Title without Assignment.
