Crawford County Sheriff's Office Press Release

The following subjects have been charged with a crime but are presumed innocent until proven guilty:

On June 21, 2024 approximately 19:30 Crawford County Deputies responded to a car/deer accident CR 500N near CR 750E in Martin Township. Reva Patton, age 70, of rural Robinson driving a 2012 Chevrolet Malibu collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was drivable from the scene.

On June 21, 2024 approximately 19:21 Crawford County Correctional Deputies arrested Amber Brown, age 39, of Robinson for; Crawford County Warrant – Failure to Appear (Unlawful Possession of Methamphetamine). Brown was extradited from the Vanderburgh County Jail in Evansville, IN back to our jail and was processed. Brown is awaiting a detainment hearing and remains in custody.

On June 21, 2024 approximately 11:36 Crawford County Deputies responded to single vehicle accident IL RT 1 near CR 1550N in Hutsonville Township. Ricky Harms, age 65, of Farmersburg, IN driving a 2003 Honda VTX went off the roadway due to unknown reasons collided with a fence causing disabling damage.
