Crawford County Sheriff's Office Press Release

The following subjects have been charged with a crime but are presumed innocent until proven guilty:

On August 15, 2024 approximately 12:29 Crawford County Deputies responded to a car/deer accident CR 1675N near CR 400E in Licking Township. Judy Mann, age 73, of Oblong driving a 2014 Dodge Grand Caravan collided with a deer causing over \$1,500 in damage. No injuries were reported but the vehicle was towed by Crouse Wrecker Service of Robinson.

On August 15, 2024 approximately 06:30 Crawford County Deputies responded to a car/deer accident IL RT 33 near CR 1300E in Robinson Township. Gracey Miller, age 19, of Palestine driving a 2018 Ford Escort collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was drivable from the scene.
