### **Crawford County Sheriff's Office Press Release**

*The following subjects have been charged with a crime but are presumed innocent until proven guilty:*

On September 13, 2024 approximately 09:07 Crawford County Deputies arrested Brandyne Cody, age 26, of Ottawa, IL for; Wisconsin DOC warrant – Disorderly Conduct, Domestic Abuse, Bail Jumping. Cody was extradited from the Robinson Correctional Center and transferred to our county jail for processing. Cody remained in custody awaiting to be extradited back to Wisconsin.

On September 12, 2024 approximately 11:33 Crawford County Deputies responded to a hit-and-run complaint in Oblong at S. Jackson and W. Main St. [UNIT 2] driven by Carole Kirk, age 78, of rural Oblong driving a 2018 Buick Enclave was traveling eastbound when a black truck unknown make or model was traveling westbound and swerved in to [UNIT 2's] lane and collided with [UNIT 2's] vehicle and causing over \$1,500 in damage. No injuries were reported and [UNIT 2] was drivable from the scene. The accident is still under investigation.

On September 10, 2024 approximately 06:19 Crawford County Deputies responded to a car/deer accident CR 1050E near CR 1450N in Robinson Township. Amanda Loftis, age 40, of rural Robinson driving a 2007 Toyota Yaris collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was able to be driven from the scene.

On September 9, 2024 approximately 10:44 Crawford County Deputies arrested Jennifer Hargrave, age 39, of rural Palestine for; Crawford County Warrant – 2 counts of Battery. The case was investigated by the Robinson Police Department. Hargrave turned herself in at the county jail and was processed through the jail and was later released after attending a detention hearing due to the Pre-trial Fairness Act. Hargrave was given an appearance date to appear.

On September 9, 2024 approximately 15:52 Crawford County Deputies arrested Monica Heleine, age 38, of Hutsonville for; Crawford County Bench Warrant / Body Attachment. Heleine turned herself in at the county jail. Heleine was processed through the jail and later posted \$250.00 + \$25.00 booking Fee and was released with a future court date to appear.

On September 07, 2024 approximately 00: 36 Crawford County Deputies assisted Sullivan County Sheriff's Deputies with vehicle pursuit that came into our county via the Hutsonville bridge. Crawford Deputies utilized spike strips and the pursuit ended on S. Rose St. in Hutsonville. A male juvenile, age 16, of Sullivan, IN and Tyderius Calvin, age 20, of Sullivan IN, were later arrested after a foot pursuit on multiple Felony Charges. Calvin charges are the following; Resisting a Peace Officer, Unlawful use of a Weapon, Unlawful Possession of a Firearm and Ammunition without a FOID card, Unlawful Possession of a Handgun, and Obstructing a Peace Officer. Deputies are petitioning the court for charges on the juvenile involved are; for Possession of a Stolen Motor Vehicle, Aggravated Fleeing and Eluding, Possession of Burglary Tools, and Criminal Damage to Property, and a traffic citation for Reckless Driving. The vehicle involved was stolen out of Vigo County Indiana 2017 White Hyundai Sonata. There will be more charges filed by the Sullivan County Sheriff's Office.
