## **Crawford County Sheriff's Office Press Release**

SHERIFF

The following subjects have been charged with a crime but are presumed innocent until proven quilty:

On October 5, 2024 approximately 11:08 Crawford County Deputies responded to a car/deer accident CR 1400E near CR 700N in Honey Creek Township. Ashley McCord, age 47, of West Union, IL driving a 2024 Kia Sportage collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle had to be towed by Crouse Wrecker Service of Robinson.

On October 3, 2024 approximately 20:17 Crawford County Deputies responded to a car/deer accident IL RT 1 near CR 250N in Montgomery Township. Edward Swartz, age 47, of Vincennes, IN driving a 2020 Nissan Sentra SV collided with a deer causing over \$1,500 in damage. [UNIT 1] was towed by Edington's Wrecker Service out of Marshall, IL and [UNIT 2] was towed by Crouse Wrecker Service out of Robinson.
