## **Crawford County Sheriff's Office Press Release**

The following subjects have been charged with a crime but are presumed innocent until proven guilty:

On October 11, 2024 approximately 11:30 Crawford County Court Security Deputies arrested Trista Brannon, age 23, of Robinson for; Drug Court Violation. Brannon was transported from the courthouse to the county jail for processing and remains in custody awaiting a future court date.

On October 11, 2024 approximately 09:47 Crawford County Deputies arrested Adam McCullough, age 33, of Vincennes, IN for; Crawford County Warrant – Retail Theft.
