Crawford County Sheriff's Office Press Release

The following subjects have been charged with a crime but are presumed innocent until proven guilty:

On October 25, 2024 approximately 18:25 Crawford County Deputies arrested Tony Russell, age 46, of Champaign, IL for; Crawford County Warrant – Failure to Appear (Unlawful Possession of Methamphetamine). Russell was extradited from the Champaign County Jail in Champaign, IL and transported back to Crawford County and remains in custody awaiting a detainment hearing.

On October 25, 2024 approximately 08:24 Crawford County Deputies arrested Lacy Wittenmyer, age 38, of Robinson for; Crawford County Warrant – Public Aid Recipient Fraud. Wittenmyer turned herself in at the county jail. Wittenmyer was processed and remained in custody until she attended a detainment hearing and was later released reference the Pre-trial Fairness Act with a future court date to appear.

On October 24, 2024 approximately 15:12 Crawford County Deputies arrested Derek Brown, age 34, of Lawrenceville, IL for; Crawford County Warrant – Violation of Probation. Brown was extradited from the Lawrence County Jail in Lawrenceville, IL and transported back to Crawford County and was later released after attending a detainment hearing reference the Pre-trial Fairness Act with a future court date to appear.

Graves was transported from the courthouse to the county jail for processing. During the jail processing Graves received additional charges of Unlawful Possession of a Controlled Substance. Graves remains in custody awaiting a detainment hearing.

On October 23, 2024 approximately 19:40 Crawford County Deputies arrested Thomas Allen, age 71, of rural Newton, IL for; Nine (9) counts of Aggravated Animal Cruelty. Allen was transported to the county jail for processing and remained in custody until Allen attended a detainment hearing and was later released reference the Pre-trial Fairness Act with a future court date to appear. Following an investigation at the 2000 block of N. 650th Street in Robinson.

On October 23, 2024 approximately 17:20 Crawford County Deputies arrested Kelsey Hetzler, age 26, of rural Robinson for; Domestic Battery. Hetzler was transported to the county jail for processing and remained in custody until attending a detainment hearing. Hetzler was later released reference the Pre-trial Fairness Act with a future court date to appear. Upon an investigation at 400 block of S. Adams St. in Oblong.

On October 23, 2024 approximately 13:50 Crawford County Deputies arrested Alicia Jayne, age 31, of Yale, IL for; Crawford County Warrant – Failure to Appear (Possession of Adult Use Cannabis in a Motor Vehicle). Jayne turned herself in at the county jail and was later released after attending a detainment hearing reference the Pre-trial Fairness Act with a future court date to appear.

On October 22, 2024 approximately 22:57 Crawford County Deputies arrested two subjects, first, Sean Gross, age 32, of Martinsville, IL for; Unlawful Possession of Methamphetamine with Intent to Deliver, Unlawful Possession of Methamphetamine, Unlawful Possession of Cannabis with Intent to Deliver, Unlawful Possession of Cannabis, Unlawful Possession of Drug Paraphernalia and issued a written warning for Improper Lane usage and Obstructed License plate. Second, Jolene Jourdan, age 50, of Robinson for; Unlawful Possession of Methamphetamine with intent to deliver, Unlawful Possession of Methamphetamine, Unlawful Possession of Cannabis with Intent to Deliver, Unlawful Possession of Cannabis, and Unlawful Possession of Drug Paraphernalia. Both were transported to the

county jail for processing and remained in custody until they attended a detainment hearing. Both were later released reference the Pre-trial Fairness Act with a future court date to appear. Upon an investigation on a traffic stop at CR 350N near CR 1600E.

On October 22, 2024 approximately 05:15 Crawford County Deputies to a car/deer accident CR 300E near CR 1400N in Oblong Township. Cy Plunkett, age 63, of Oblong driving a 2007 Toyota Rav4 collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was drivable from the scene.

On October 21, 2024 approximately 07:12 Crawford County Deputies responded to a car/deer accident CR 100N near CR 1300E in Honey Creek Township. Stacey Emmons, age 44, of rural Flat Rock driving a 2004 Chevrolet Tahoe collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was drivable from the scene.

Padrick was transported to the county jail for processing then later released reference the Pre-trial Fairness Act with a future court date to appear. Following a traffic stop on IL RT 33 near CR 800E.

On October 20, 2024 approximately 18:18 Crawford County Deputies responded to a car/deer accident CR 900N near CR 850E in Robinson Township. Tyler Beard, age 23, of rural Robinson driving a 2021 GMC Sierra collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was drivable from the scene.

On October 19, 2024 approximately 16:22 Crawford County Deputies responded to a suspicious person call near the 200 block of S. Leaverton St. in Palestine. Deputies arrested Caleb Correll, age 28, of Palestine for; Unlawful Possession of Methamphetamine, Unlawful Possession of Drug Paraphernalia, and Crawford County Body Attachment/Bench Warrant. Correll was transported to the county jail and remained in custody until he attended a detainment. Correll was later released reference the Pre-trial Fairness Act with a future court date to appear.

On October 19, 2024 approximately 06:34 Crawford County Deputies responded to a car/deer accident CR 800N near CR 600E in Oblong Township. Lora Jackson, age 53, of rural Oblong driving a 2012 Dodge Ram owned by Gary Barnbrook collided with a deer causing over \$1,500. No injuries were reported and the vehicle was drivable from the scene.

On October 19, 2024 approximately 06:03 Crawford County Deputies responded to a single vehicle accident CR 200E near CR 500N in Oblong Township. Trisha Rodgers, age 54, of Oblong driving a 2010 Hyundai Tucson, deputy advised in his report; [UNIT 1] was traveling northbound on CR-200E, 0.23 miles north of CR-500N when [UNIT 1] ran off the roadway crossing the southbound lane and continuing into the culvert on the west side of the southbound lane. [UNIT 1] continued over the culvert into the field on the west side of the road and overturned on its passenger side where it came to rest. [UNIT 1] caught fire briefly and was extinguished by Oblong Fire Department. [UNIT 1] driver was transported to Deaconess Midtown in Evansville, IN via Air Evac. [UNIT 1] passenger was transported via United Life Care Ambulance to Crawford Memorial Hospital and later released. Over \$1,500 in damage was reported and due to the damage Crouse Wrecker of Robinson towed the vehicle. Crawford County Rescue was also dispatched to the scene.

On October 19, 2024 approximately 03:39 Crawford County Deputies responded to a 911 hang up call coming from the area of the 100 block of S. Range Street in Oblong. Upon an investigation deputies arrested Andrew Doucet, age 35, of Oblong for; Home Invasion and Criminal Damage to Property. Doucet was transported to the county jail for processing and remained in custody until Doucet attended a detainment hearing and was later released reference the Pre-trial Fairness Act with a future court date to appear.

On October 18, 2024 approximately 23:18 Crawford Deputies arrested Coltin Woods, age 29, of Palestine for; Unlawful Possession of Methamphetamine with Intent to Deliver, and Unlawful Possession of Methamphetamine. Woods was transported to the county jail for processing and remained in custody until Woods attended a detainment hearing and was later released reference the Pre-trial Fairness Act with a future court date to appear. Upon an investigation on a traffic stop 2100 block of E. Main Street in Robinson.

On October 18, 2024 approximately 19:29 Crawford County Deputies arrested Paul Garrard, age 44, of Palestine for; Crawford County Bench Warrant/Body Attachment. Garrard was transported to the county jail and processed. Garrard later posted bail of \$250.00, plus a \$25.00 Booking Fee and was released. Warrant Service near the 600 block of W. Franklin Street in Palestine.
