Crawford County Sheriff's Office Press Release

The following subjects have been charged with a crime but are presumed innocent until proven guilty:

On November 8, 2024 approximately 18:33 Crawford County Deputies responded to a car/deer accident CR 1150N near CR 1700E in LaMotte Township. Zachary Liddle, age 27, of Robinson driving a 2006 Chevrolet Pickup collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was drivable from the scene.

On November 7, 2024 approximately 18:25 Crawford County Deputies responded to a car/deer accident CR 2000N near CR 900E in Prairie Township.
