Crawford County Sheriff's Office Press Release

The following subjects have been charged with a crime but are presumed innocent until proven guilty:

On November 15, 2024 approximately 19:58 Crawford County Deputies responded to a car/deer accident IL RT 33 near CR 800E in Robinson Township. A Male juvenile, age 17, of Robinson driving a 2017 Buick Regal owned by Eric Erickson collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was drivable from the scene.

On November 14, 2024 approximately 18:12 Crawford County Deputies responded to a car/deer accident CR 1050N near CR 725E in Oblong Township. Tyler Davis, age 38, of rural Oblong driving a 2015 Dodge Utility collided with a deer causing over \$1,500 in damage.
