Crawford County Sheriff's Office Press Release

The following subjects have been charged with a crime but are presumed innocent until proven guilty:

On December 10, 2024 approximately 23:16 Crawford County Deputies arrested Jeffrey McIntosh, age 56, of Flat Rock for; Driving Under the Influence (A3) Intoxicating Compounds, and Improper Lane Usage. McIntosh was transported to the county jail for processing and was later released reference the Pre-trial Fairness Act. Following a traffic stop on CR 100N near CR1300E.

On December 10, 2024 approximately 07:08 Crawford County Deputies arrested Christopher Carbonneau, age 32, of rural Robinson for; Crawford County Warrant – Domestic Battery. Carbonneau turned himself in on the warrant at the county jail. Carbonneau was processed through the jail and later went to a detainment hearing and was released reference the Pre-trial Fairness Act with a future court date to appear.

On December 10, 2024 approximately 01:25 Crawford County Deputies responded to a car/deer accident IL RT 1 near CR 1700N in Hutsonville Township. Joseph Hadden, age 54, of Roseville, IL driving a 2018 Freightliner Sprinter 3500 owned by West Shore Freight, LLC collided with a deer causing over \$1,500 in damage. No injuries were reported, but due to the damage Edington's Wrecker Service out of Marshall, IL towed the vehicle from the scene.

On December 9, 2024 approximately 13:28 Crawford County Deputies responded to a single vehicle accident CR 800E near CR 1450N in Robinson Township. Arvin Moden, age 75, of rural Oblong driving a 1994 GMC Sonoma ran off the roadway in to a ditch and then collided with a utility pole and guide wire owned by Norris Electric Corp, Newton, IL. No injuries were reported, but due to the damage Shook's Wrecker Service of Robinson towed the vehicle from the scene.

Ronald Langley, age 67, of Palestine driving a 2014 Chevrolet Silverado collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle was able to be driven from the scene.

On December 7, 2024 approximately 00:21 Crawford County Deputies responded to a car/deer accident IL RT 33 near CR 700N in Montgomery Township. Jonathan Clark, age 42, of Vincennes, IN driving a 2007 Pontiac G5 collided with a deer causing over \$1,500 in damage. No injuries were reported and the vehicle stayed on scene off the roadway waiting to be towed at a later time.
